### Biography

Justin practices mainly in the areas of administrative law, quasi-criminal prosecution and defence, and civil litigation.

As part of his administrative law practice, Justin has successfully prosecuted several anti-doping cases for the Canadian Centre for Ethics in Sport, including acting as the lead counsel in the only anti-doping appeal to be heard in Canada (where his client was successful in overturning the original decision). Justin also prosecutes and defends cases before a variety of other administrative tribunals, including the Ontario Securities Commission, the Ontario Energy Board and academic discipline tribunals. He regularly represents clients in related judicial review applications and appeals before the Divisional Court.

In his civil litigation practice, Justin focuses on contract law, defamation and cases raising human rights issues. He is an experienced litigator, having appeared as counsel before arbitrators, administrative tribunals, every level of court in Ontario, and four times before the Supreme Court of Canada.

Justin teaches administrative law at Osqoode Hall Law School's Professional LLM program, and writes frequently on legal topics in both industry and mainstream publications. He is the coeditor of the Stockwoods LLP Administrative and Regulatory Law Case Review. Following law school, he clerked for the Honourable Justices Laskin, Goudge and MacFarland at the Court of Appeal for Ontario.

### Representative Work

- ➤ Co-counsel to the Canadian Centre for Ethics in Sports in a number of anti-doping hearings, including three involving Pan Am and Olympic bound athletes who tested positive for prohibited substances.
- > Joint Coroner's Inquest into the Deaths of Seven First Nations Youths in Thunder Bay. Part of Stockwoods team representing Thunder Bay Police Service and Thunder Bay Police Services Board in one of the longest inquests in Ontario's history.
- First Nations Child and Family Caring Society v. Attorney General of Canada, 2016 CHRT 2. Represented an interested party in this groundbreaking human rights case, where the Canadian Human Rights Tribunal found that the government's funding scheme for First Nations children living on reserves amounted to discrimination.
- Ontario (Attorney General) v. Kittiwake Sailboat, 2015 ONSC 6106. Appointed amicus curiae in this civil forfeiture proceeding, with application judge Corbett J. noting that Mr. Safayeni's "excellent submissions were of great assistance to the court."
- > Tsilhqot'in Nation v. British Columbia, [2014] 2 SCR 257. Lead counsel for interveners in this leading decision on the test for aboriginal title.
- Siskinds LLP v. Canadian Imperial Bank of Commerce, 2014 ONSC 3983, aff'd 2015 ONCA 265. Resisted summary judgment, and succeeded in having the action dismissed in its entirety, based on the proper interpretation of a commercial contract.
- ➤ In the matter of Energy Syndications Inc., OSC Decision released November 27, 2013. Counsel to individual respondent in this sanctions hearing, and successfully obtained rare order of partial (vs full) disgorgement of profits, based on mitigating circumstances.
- ➤ Goldcorp Canada Ltd. v. Ontario Energy Board, 2012 ONSC 3097 (Div Ct); Pollution Probe Foundation v. Ontario Energy Board, 2012 ONSC 3206 (Div Ct). Acted for the Energy Board in these appeals that sought to attack a decision of the Board as unreasonable and lacking jurisdiction, and successfully had both appeals dismissed.
